#### 1. REPORT FROM SEXUAL HARASSMENT COMMITTEE

Academic Year	Annual Report
2018-2019	<p>A five member Anti Sexual Harassment Committee was formed. The committee had its first annual meeting for the Academic session was held on where its objectives, functions and plans were discussed and chalked out. It was decided that the committee will take up and consider Sexual Harassment complaints from students as well as from faculty members within the college campus. The committee shall issue warnings, impose fines and suspensions, and take legal actions according to the severity of the case. The committee took time to give awareness of the issue to all students during the students' briefing program which was held on and also during the PTA meeting and Fresher's Social held on and respectively. There was no complaint received during the session.</p>
2019-2020	<p>A complaint box was installed where students or any of the students may drop their written complaints about sexual harassment. This action was taken by the Anti-Sexual Harassment Committee after its first meeting for the session where it was discussed that there can be a possibility of cases where students are hesitant to report cases of misconduct and harassment out of fear and prefer to disclose anonymously or indirectly. The complaint box was opened every month by the committee. No complaints regarding sexual harassment were found throughout the session. Awareness on Anti Sexual Harassment and the availability of complaint box was also mentioned and highlighted during college functions such as Freshers' Social on, Students Briefing on and all major college gatherings.</p>
2020-2021	<p>Anti-Sexual Harassment posters are made and displayed in three different locations within the college campus i.e, one in Arts block, one in Science block and one in the administrative block. This was done in pursuit of the</p>

	committee's decision in its first meeting for the session on where its activities are reviewed and plans are chalked out to create more awareness and innovative progress in spreading awareness of the matter. As practised in previous years, Anti sexual Harassment awareness is highlighted in all student gatherings throughout the session. The complaint box was also opened monthly by the committee and no complaints were found. Review meeting was held on at the close of the academic session for the year.
2021-2022	The committee had its first meeting on. As decided in the meeting, awareness on anti sexual harassment was highlighted in all student gathering programs. The complaint box was opened every month and no complaint was received till the end of the session. The meeting of the committee at the end of the session held on reviewed the activities and resolved that the ongoing practice of the committee i.e. awareness programs etc. should be continued and improvised as required in the coming sessions.
2022-2023	The Anti-Sexual Harassment Committee had its first annual meeting on. It was discussed and agreed that anti sexual harassment awareness being highlighted in all major college gatherings has been successful and effective and should be continued. Subsequently the highlights of the issue was made in gatherings such as Student' briefing sessions, Fresher's Social, Parting Social etc. The complaint box was opened every month by the committee and no complaints were found.

## **2. REPORT FROM ANTI RAGGING COMMITTEE**

Academic Year	Annual Report
2018-2019	In pursuance to the judgement of Supreme Court of India dated 08.05.2009 in civil Appeal No. Gg7/2009 and the UGC notification on “Regulation Curbing the Menace of Ragging in Higher Educational Institution, 2009: Lunglei Govt. College set up an Anti-Ragging Committee. The Committee organizes awareness campaigns among the students every academic session and constitutes Anti-Ragging Squad team functioning under the supervision of the committee. The Committee also put up complaint box in the College, the Complain Box is opened every week, but not even a single complaint was reported during the Academic session.
2019-2020	Ragging is strictly forbidden in or outside the College campus. Anti-Ragging Committee is constituted in this College to prevent ragging and to take anti-ragging measures as per the guidelines issued by the Supreme Court of India and UGC. All students shall familiarize themselves with rules/ regulations/ guidelines of the College. The institution is organising counselling sessions for the newcomers every year. The Committee is taking all necessary measures for prevention of ragging inside the campus / hostels.
2020-2021	It was a period of Covid-19 and the pandemic of Covid-19 brought with it an abrupt lockdown affecting the College and impacting our lives. Leaving us to navigate the significant changes to work and lifestyle. There can be no offline teaching and our core activities of education and learning were still carried out through online classes. No activities were undertaken by Anti-Ragging Committee due to pandemic.
2021-2022	The pandemic has still created disruption in our educational institutions. Lockdown and staying home strategies have been put in place as the needed action to flatten the curve and control the transmission of the disease. Due to this pandemic it was impossible to organize meetings and activities during the academic year 2021-2022.
2022-2023	Anti-Ragging Committee is constituted in this College to prevent ragging and to take anti-ragging measures as per the guidelines issued by the Supreme Court of India and UGC. The Committee prevent the risk of ragging and maintain healthy relations among the students in the college campus. Ragging is strictly prohibited in the college campus. In

the Academic year 2022-2023, the college students are informed about Anti Ragging through counselling sessions. Fortunately during this academic year no ragging case is reported in the campus.
