Lunglei Government College is an affiliated college to Mizoram University therefore curriculum designing and revision are made by the University wherein faculties of the college actively participate. The syllabi designed imbibe a learning outcome based curriculum which emphasizes student centric learning. The curriculum focuses on Environmental Issues, Changing Roles of Women, Suffrage and Women's Movement, Gender and Enlightenment, Human Right Education and Peace Education, Environmental Economics, Ecology and Wild Life, Physical Geography, Ethics, Ethonobotany and Natural Resource Management. The College follows a broad Academic Calendar prepared by Mizoram University each year. Conforming to the Mizoram University Academic Calendar, the college prepares an institutional calendar showing the timeline of college admissions, commencement of classes, continuous internal assessments, and examinations. Each department and Committee also creates its calendar of events. The College has collaborated with National Institute of Electronics and Information Technology and is a NIELIT Study Centre. The certificate courses under this collaboration include, CCC (Course on Computer Concepts), Fundamentals of Computer, Operating Systems, Office Automation, Networking and Internet, Digital Finance Tools and Application and O Level.

The college adopts several measures to nurture problem solving and participatory learning. Besides the usual assignments students are given important brain storming sessions to give presentations on pertinent issues and topics from the syllabi. Students are taught the application of knowledge to real life situations beyond classrooms, opportunities for hands on learning are given and encouraged to participate in competitions like quizzes, seminars and workshops at various college or state level. Recurring programs like college weeks and Students Union election inculcate effective skills in creative expertise in arts and crafts. The college encourages use of ICT tools at all suitable areas. Wi-Fi is made available in each block of academic building. The Academic Council of the college prepares academic calendar. Using online platforms, reading material is made available to students through WhatsApp and e-mails. Continuous Internal Assessments (CIA)are conducted twice per semester. Assignments, projects and presentations are considered as part of Continuous Internal Assessment. NIELIT Study Centre in the college invites admission for course on computer concepts. Faculties are encouraged to adopt innovative techniques IT and pedagogies while teaching. Suggestions for improving current practices are shared and delivered at review and preview meetings. To encourage awareness on natural resource, biodiversity and conservation, environmental pollution, social issues and development --a course- environmental issues is introduced changing roles of nature gender role and sexual evolution, Gender and Enlightment are some of the courses included in the curriculum. More ever, HEREUS, the online college portal is maintained where by or CGPA serves as effective tool for assessing program outcome (PO).

The college is taking efforts to enhance innovation wherein faculties are involved in activities in collaboration with government organizations in the capacity of Master Trainers. The collaborations are with High Powered Committee Lunglei Department of Planning and Program Implementation, Government of Mizoram, Indian Institute of Entrepreneurship (IIE) Guwahati Ministry of Skill Development and Entrepreneurship Development Centre and Incubation Centre in North Eastern Region's educational institutions. Also a nodal Centre is established in the college under Directorate of Science and Technology Government of Mizoram. Faculty members from department of mathematics and geology have ongoing major research projects. The college regularly conducts and organizes drives for blood donation, plantation, cleanliness etc. The college has an Intellectual Property Cell, with a Nodal Officer, and a dedicated committee associated with it. It organises talks and meetings for awareness on various intellectual property rights. Joint programme on Protection of Plant Varieties had also been organised with the Department of Botany of the college, as the core undergraduate syllabus has intellectual property rights in its main curriculum. The Cell is also associated with the Patent Information Centre under Mizoram Science, Technology and Innovation Centre (MISTIC), Directorate of Science & Technology, Government of Mizoram, hence the designation of Nodal Officer.

The college has a campus of about 5 acres which is well maintained. There are 2 academic buildings as Arts and Science blocks along with a Multipurpose Hall, A Library, Auditorium and Students' Union room. Most of the classrooms are equipped with ICT tools like projectors, white boards and wi-fi. There are classrooms for lectures and laboratories for science experiments. The college provides Wi-Fi supplemented by 100 Mbps connectivity to all classrooms and offices. There is a Language Laboratory. The college library is automated with Integrated Library Management System. Each classroom is electrified and supported by a back-up system in case of power failure. The college has installed a Diesel Generator with a capacity of 20 KVA electricity. The library maintains a collection of books, reference books, journals. The E-Resource Centre has been established at the library with an installed infrastructure of desktop computers; separately for male and female students. OPAC (Open Public Access Catalogue) and designated Bar code has been activated. Library automation has been initiated, and is using SOUL (Software for University Libraries) provided by INFLIBNET for book's keeping. In order to accommodate students coming from outside Lunglei, the college has two Girls' Hostel buildings with one Hostel Warden Quarters located inside the Campus with a limited seat of 36 beds and Boys' Hostel with 12 bedded capacities. The college also has staff quarters.

Majority of students in the college get scholarships from the state and central government (about 76%). The college conducts various programs on soft skills, entrepreneurship, career opportunities. Programs are also conducted to develop language and communication skills through competitions such as youth parliament. Training for yoga and welfare are conducted. Computing skill enhancement programs are conducted and career counselling programs guidance for joining armed forces have been organized. Guidance for appearing in competitive exams are also given to students. Lunglei Govt. College students have won university level competitions. A painting competition organized by Ministry of Tribal Affairs Government of India in which student of the college has received recognition. Alumni Association is yet to be registered but the Alumina extend cooperation to the college. About 26% of students progress for higher education after passing out from the college. The College has an Alumni Association established in 2016. The Alumni Association is involved in the administrative bodies of the institution and participates in College development. They also have representatives in the Committee of IQAC and assists the Committees under IQAC. The members of the Alumni Association work towards improvement of the college through a feedback system and the suggestions are considered for the welfare of the College as a whole. The college also invites the former faculty members of the institution for various functions and keeps in touch with them. Their feedback and suggestions are taken into account in the implementation of different programmes of the college.

### Qualitative analysis of Criterion 6

The college is under the governance and jurisdiction of the State Government (Higher and Technical Education) and the Mizoram University for its administrative/ financial and academic purpose respectively. Day to day administration is looked after by the principal with assistance from the Core committee and others. Allotment of funds for purchase are normally conveyed to various departments through their heads of

department, the student union bodies also get duly included in decision making in organising sports and cultural activities. Institutional plans from admission to University examination are meticulously chocked out by relevant committees. Departments have autonomy to implement their own plans after taking approval from the Principal and Academic Council. There is staff welfare committee which extends financial assistance in the form of loans and other matters. Employee's performance is reviewed annually, and promotions are based on a points system called the API score. The College places great value on accountability and has hence devised an inbuilt mechanism whereby the competence and efficiency of both the teaching and the non-teaching personnel are assessed in a time bound manner. For instance, surveys are conducted among the students to generate data on the performance of the college staff. The results of the surveys are then communicated to the stakeholders to enable them to take remedial measures for improving the quality of their work in the college. Complaints over the conduct and poor performance of the college faculty are dealt with by the Principal. Complaint Boxes or Suggestion Boxes are placed in the Arts and Science Blocks within the campus. These Complaint Boxes are opened from time to time and on the basis of these complaints from the students, the Principal takes suitable actions to address and remedy the problems and issues raised by the students.

The College has got water harvesting system which collects about 1 lakh Litres of water collected in the tank which is constructed for the purpose.
